That I, Homer Styles

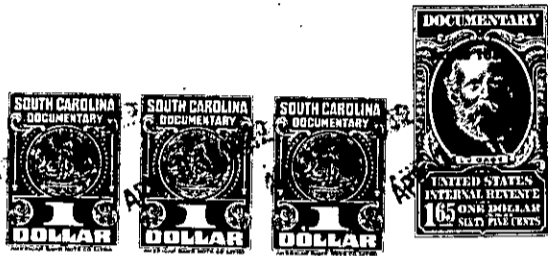
in consideration of the sum of Fifteen Hundred and no/100 (\$1500.00) in the State aforesaid, DOLLARS,

Huff and Sarah S. Huff, their heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 46 of Grand View Heights, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book EE at Page 150, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Grand View Circle; at joint front corner of Lots Nos. 44 and 46, and running thence with the line of said lots, N. 13-35 W. 200 feet; thence S. 70-15 W. 100 feet; thence S. 13-35 E. 200 feet to an iron pin on Grand View Circle; thence with Grand View Circle, N. 70-15 E. 100 feet to the point of beginning.
