W. L. West, his heirs and assigns forever:

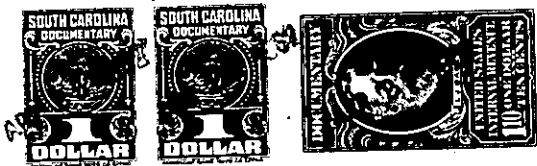
