in consideration of the sum of Twelve Hundred Fifty and no/100 (\$1250.00)-----in the State aforesaid, DOLLARS,

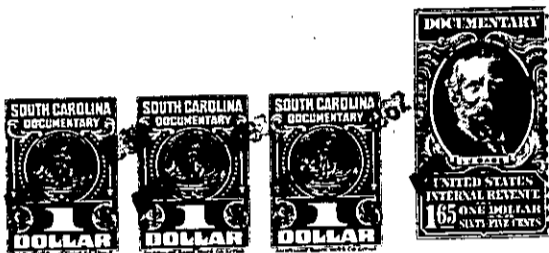

Office for Greenville County in Plat Book MM, Page 29 and having, according to said plat, the following metes and bounds, to-wit:
