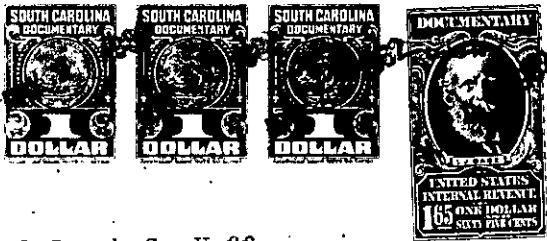

ALL that piece, parcel or lot of land in Bates Twp., Greenville County, State of South Carolina, located on the north side of Grand View Circle, near Travelers Rest and being the west 67.5 feet of Lot 46 of Plat of Property of Homer Styles and having the following Metes and Bounds:
