in consideration of One and No/100 (\$1.00), love and affection - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto George Robinson, his heirs and assigns forever:

All of our right, title and interest in and to the following described real estate:

All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, located near Saluda Lake as is more fully shown on a plat of property of George Robinson prepared by Webb Surveying and Mapping Company, April 20, 1962 and recorded in the R.M.C. Office for Greenville County in Plat Book _____, at Page _____ and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of a driveway at the corner of property now or formerly of Theodore and running thence with the line of property now or formerly of Theodore, N. 44-30 W. 405 feet to an iron pin which is located 1007 1/2 feet more or less, southwest of Saluda Lake and running thence along the line of property now or formerly of Robinson, S. 6-30 W. 275 feet to an iron pin and running thence along the line of property now or formerly of Robinson, S. 44-30 E. 405 feet to an iron pin and running thence N. 6-30 E. 275 feet to the point of beginning;
