KNOW ALL MEN BY THESE PRESENTS, that I, T. D. Butler, Clerk of Court, South Carolina

in consideration of Ten and No/100 (\$10.00) - - - - - Dollars,
and assumption of mortgage set out below
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Paul H. Butler, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. 14 of the property of F. H. Earle as shown on a plat thereof prepared by Pickell and Pickell, Engineers, February 26, 1951 and recorded in the R.M.C. Office for Greenville County in Plat Book Z, at page 191, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Wallace Street, joint front corner of Lots 13 and 14, and running thence along the east side of said street, N. 25-38 E. 110 feet to an iron pin, corner of Lot 15; thence along the line of that lot, S. 64-22 E. 133.2 feet to an iron pin, joint rear corner of Lots 11 and 12; thence along the rear line of Lot 12, S. 48-53 W. 119.7 feet to an iron pin, joint rear corner of Lots 12 and 13; thence along the line of Lot 13, N. 64-22 W. 85.9 feet to an iron pin, the beginning corner; being the same property conveyed to me by Willard Clifford Rogers by his deed dated February 16, 1957 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 571, at Page 263.

As a part of the consideration for this conveyance, the grantee expressly assumes and agrees to pay the balance due on that certain note and mortgage, in the original sum of \$9,000.00 executed by Willard Clifford Rogers to the First Federal Savings and Loan Association of Greenville and recorded in the R.M.C. Office for Greenville County in Mortgage Book 623, at Page 428, the balance due thereon being the sum of \$ 6,884.98 as of this date.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
