KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore

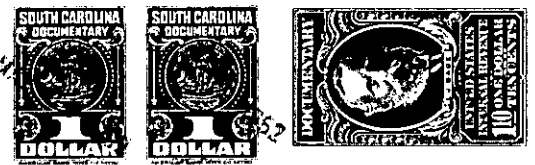
in consideration of Six Hundred Eighty & No/100 (\$680.00) - - - - - Dollars,
