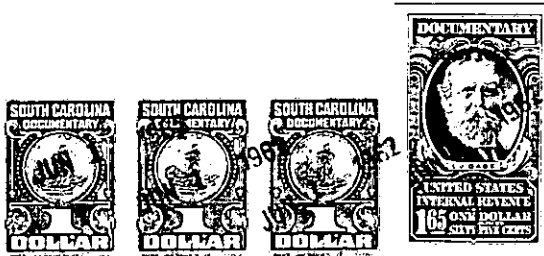
in consideration of the sum of Twelve Hundred Fifty and no/100 (\$1250.00) in the State aforesaid, DOLLARS.

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina being shown as Lot No. 8, Section A on a Plat of Oak Hill, recorded in the R.M.C. Office for Greenville County in Plat Book MM, Page 29 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Good Street at the joint front corner of Lots 7 and 8 and running thence with the common line of said lots N. 67-51 W. 150 feet to an iron pin; thence S. 22-09 W. 75 feet to an iron pin; thence S. 67-51 E. 150 feet to a concrete monument on the northwesterly side of Good Street; thence with said street N. 22-09 E. 75 feet to the point of beginning.
