KNOW ALL MEN BY THESE PRESENTS, that we, Ernest M. Horton and Keeter P. Horton,

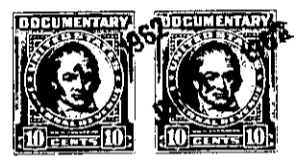
in consideration of Eleven Thousand Eight Hundred and No/100 (\$11,800.00)----- Dollars,
