KNOW ALL MEN BY THESE PRESENTS, that I, J. Mac Bruce,

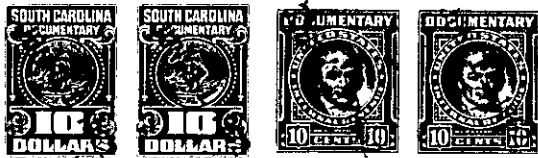
in consideration of Eleven Thousand Six Hundred Fifty and No/100 (\$11,650.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto B. G. McDavid, his Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southwestern side of French Lane and being known and designated as Lot No. 116 of Pine Hill Village as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "QQ", at Page 169 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of French Lane at the joint front corner of Lots Nos. 80 and 116 and running thence along said Lane, S. 79-11 E. 13 feet to an iron pin; thence with the curve of said Lane, the chord of which is S. 48-11 E. 59.8 feet to an iron pin; thence continuing with said Lane, S. 17-04 E. 80 feet to an iron pin; thence along the line of Lot No. 117, S. 82-35 W. 91.4 feet to an iron pin; thence N. 79-11 W. 10 feet to an iron pin; thence N. 8-40 E. 130.2 feet to an iron pin, the point of beginning.
