in the State aforesaid, in consideration of the sum of Twenty Two Hundred Fifty and no/100 (\$2250.00)-----DOLLARS,

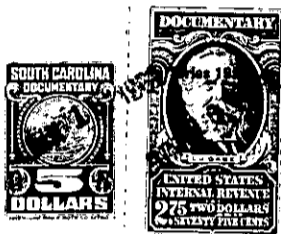

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 42 on a plat of Indian Hills, plat of which is recorded in Plat Book QQ at Page 11 and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Hunts Bridge Road at joint front corner of lots Nos. 41 and 42 and running thence with the line of said lots N. 82-35 E. 180 feet; thence N. 7-25 W. 100 feet; thence S. 82-35 W. 180 feet to an iron pin on Hunts Bridge Road; thence with Hunts Bridge Road S. 7-25 E. 100 feet to the point of beginning.
