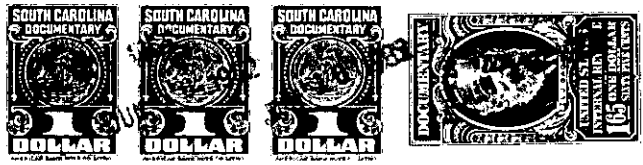
KNOW ALL MEN BY THESE PRESENTS, that I, J. H. Mauldin, of Greenville County,

in consideration of Fifteen Hundred and No/100 - - - - - (\$1500.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Mauldin Construction Co., its successors and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as Lot No. 12 of a subdivision known as Swanson Court as shown on plat thereof prepared by C. C. Jones, C. E., April, 1962 and recorded in the R. M. C. Office for Greenville County in Plat Book YY, at page 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Swanson Court, the joint front corner of Lots 11 and 12, and running thence along the joint line of said lots, N. 33-00 E. 151.6 feet to an iron pin on the bank of Richland Creek; thence continuing along the joint line of said lots, N. 33-00 E. 20 feet, more or less, to a point in the center line of Richland Creek, the joint rear corner of said lots; thence along the center line of Richland Creek, a traverse line being N. 56-05 W. 85 feet to a point in the center of said creek, the joint rear corner of Lots 12 and 13; thence along the joint line of said lots, S. 33-00 W. 25 feet, more or less, to an iron pin; thence continuing along the joint line of said lots, S. 33-00 W. 152.5 feet to an iron pin on the northern side of Swanson Court; thence along the northern side of Swanson Court, S. 57-00 E. 85 feet to the beginning corner; being a portion of the property conveyed to me by Dorothy H. Davenport, et al. by deed dated March 30, 1954 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 498, at page 489.
