in consideration of the sum of Fifteen Hundred and no/100 (\$1500.00)----- in the State aforesaid, DOLLARS,

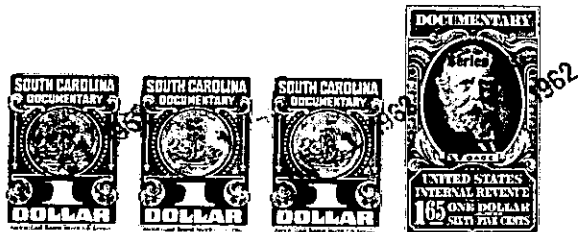

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 97 on a plat of Western Hills recorded in the R.M.C. Office for Greenville County in Plat Book QQ, Pages 98-9 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Tucson Drive at the joint front corner of lots 97 & 98 and running thence with the common line of said lots S. 16-43 E. 174.7 feet to an iron pin; thence N. 73-30 E. 64.6 feet to an iron pin; thence N. 71-32 E. 46.4 feet to an iron pin; thence N. 20-19 W. 175 feet to an iron pin on the southerly side of Tucson Drive; thence with said Drive S. 71-41 W. 63.8 feet to an iron pin; thence S. 73-17 W. 36.2 feet to the point of beginning.

The above lot is conveyed subject to the recorded restrictions applicable to Western Hills and to the set-back line as shown on said plat.
