KNOW ALL MEN BY THESE PRESENTS, that I, J. H. Mauldin, of Greenville County,

in consideration of Fifteen Hundred and No/100 - - - - - (\$1500.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Mauldin Construction Co., its successors and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as Lot No. 8 of a subdivision known as Swanson Court as shown on plat thereof prepared by C. C. Jones, C. E., April, 1962 and recorded in the R. M. C. Office for Greenville County in Plat Book YY, at page 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Swanson Court, joint front corner of Lots Nos. 7 and 8, and running thence along the joint line of said lots, S. 35-40 W. 133.5 feet to an iron pin on the subdivision boundary line; thence along the subdivision boundary line, S. 66-04 E. 177.8 feet to an iron pin at the joint rear corner of Lots Nos. 8 and 9; thence along the joint line of said lots, following the center line of a 10-foot drainage easement, N. 8-31 W. 118 feet to an iron pin on the turnaround at the end of Swanson Court; thence following the curvature of said turnaround, the chord being N. 54-53 W. 57 feet to an iron pin; thence continuing with the curvature of Swanson Court, the chord being N. 38-34 W. 37.8 feet, to the beginning corner; being a portion of the property conveyed to me by Dorothy H. Davenport, et al. by deed dated March 30, 1954 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 498, at page 489.
