in consideration of Twenty Eight Hundred Two and 50/100----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto L. C. Craig, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as lot #30, of a subdivision known as Wellington Green as shown on a plat thereof prepared by Piedmont Engineering Service, dated September 1961, recorded in the R.M.C. Office for Greenville County in Plat Book YY at Page 29, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern edge of Rollinggreen Road, the joint front corner of lots #30 and #31, and running thence along the line of these lots, S. 33-15 E. 175 feet to an iron pin; running thence N. 44-07 E. 154.4 feet to an iron pin at the joint rear corner of lots #29 and #30; running thence N. 57-40 W. 175 feet to an iron pin on the eastern edge of Rollinggreen Road; running thence along the eastern edge of Rollinggreen Road, which line is curved, the chord of which is S. 43-33 W. 80 feet to an iron pin, point of beginning.

The above described lot is a portion of that property conveyed to me by Cora C. Howell by her Deed dated April 9, 1914, and recorded in the R.M.C. Office for Greenville County in Deed Vol. 60 at page 130.

It is understood and agreed that this conveyance is subject to certain restrictions and protective covenants applicable to Wellington Green Subdivision recorded in the R.M.C. Office for Greenville County in Vol. 685, at page 135.
