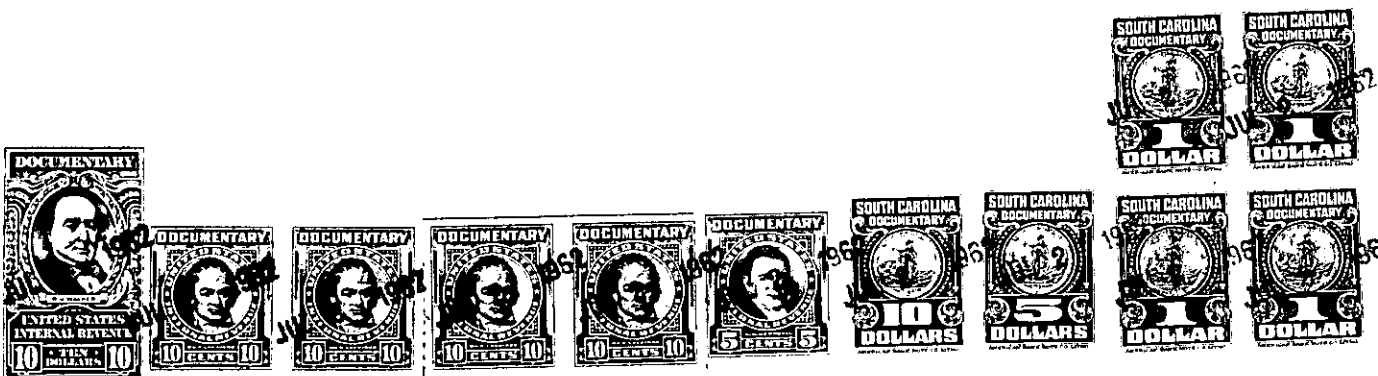
KNOW ALL MEN BY THESE PRESENTS That DEMPSEY CONSTRUCTION COMPANY, INC., FORMERLY DEMPSEY WINDOW COMPANY, INC. a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at

Greenville, in the State of South Carolina, for and in consideration of the sum of Nine Thousand Five Hundred and No/100ths (\$9,500.00)----- dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto DALLAS W. DAVIS:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 34, Section A, as shown on a plat prepared by J.C. Hill, dated November 30, 1957, entitled "Final Plat, Oak Hill, Sections A & B", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 121 at page 29, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Good Street at the joint front corner of Lots Nos. 33 and 34, and running thence with the line of Lot No. 33 S. 67-30 E. 94.8 feet to an iron pin; thence N. 35-43 E. 72.4 feet to an iron pin at the joint rear corner of Lots Nos. 34 and 37; thence with the line of Lot No. 37 N. 62-32 W. 112.2 feet to an iron pin on the Southeastern side of Good Street; thence with the Southeastern side of Good Street S. 22-09 W. 80 feet to the point of beginning.

This is a portion of the property conveyed to Dempsey Window Co., Inc. by deed of J. Frank Williams, dated February 7, 1962, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 692 at page 144. By Amendment of Charter dated June 29, 1962, the name of the said Dempsey Window Company, Inc. has been changed to Dempsey Construction Company, Inc.



Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, his successors, heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his successors, heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
