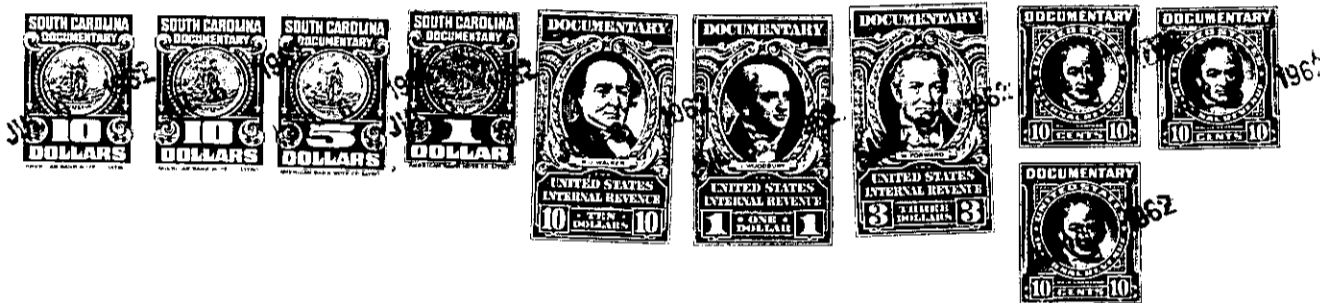
KNOW ALL MEN BY THESE PRESENTS, that G. E. Steele
