OSCAR A. CANTRELL, HIS HEIRS AND ASSIGNS FOREVER:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, and according to a plat of J. Coke Smith, Surveyor, dated January 26, 1957, of a plat of the M. C. Moon property, being more particularly described as follows to-wit:

BEGINNING at an iron pin on the north side of a surface treated road, the southwest corner of the lot herein conveyed, running thence N 2-40 E., 468 feet to an iron pin; thence continuing 10 feet to the center of a branch; thence running up said branch S. 73-33 E, 65 feet to a point; thence S. 3-00 E 15 feet to an iron pin; thence continuing along the same bearing 425 feet to an iron pin at the edge of surface treated road; thence S 76-40 W, 110 feet to an iron pin, the BEGINNING point.

This lot of land contains eighty-nine one hundredths (.89) acre, more or less, and is bounded on the north by the branch, on the east by lot previously conveyed to John Lesley, on the south by surface treated road and on the west by other property of the grantor.
