C., in plat book P at pages 18 & 19 and having according to said plat, the following metes & bounds

BECENNING at an iron pin on the Northeast side of Sunset Drive at joint front corner of lots 73 & 74 and runs thence along the northeast side of Sunset Drive S 41-10 E, 96 feet to an iron pin; thence along line of property now or formerly of J.R. Jenkinson Estate, N 55-30 E, 176.15 feet to an iron pin on the southwest edge of a five foot strip of land reserved for utilities; thence along the southwest edge of the five foot strip of land reserved for utilities, N 41-10 W, 106.1 feet to an iron pin in the rear line of lot 74, said pin being located 10 feet in a southeasterly direction from the joint rear corner of lots 72 & 74; thence in a straight line in a southwesterly direction 175 feet more or less to the beginning.
