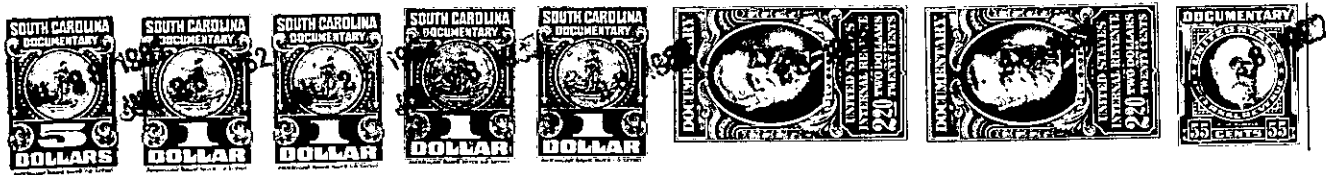
in consideration of Four Thousand Two Hundred and no/100 Dollars,
