KNOW ALL MEN BY THESE PRESENTS, that I, Troy D. Vaughn

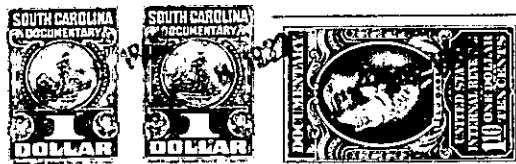
in consideration of Ten Dollars and other considerations Dollars,
