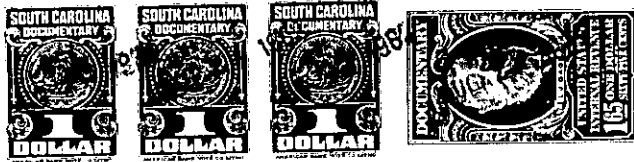
All that certain piece, parcel or lot of land with any improvements thereon situate, lying and being on the northeastern side of West Castle Road in Pine Hill Village, Gantt Township, Greenville County, South Carolina, shown and designated as Lot 125 on a plat of Pine Hill Village, prepared by R. K. Campbell, R.L.S., dated July 9, 1962, and recorded in the Office of the R.M.C. for said County and State in Plat Book 22, at Page 168, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the eastern edge of West Castle Road, joint corner of Lots 125 and 126, and running thence S. 79-11 E. 140 feet along the joint line of said lots to an iron pin, joint rear corner of Lots 125, 126, 74 and 75; thence S. 10-49 W. 75 feet along the joint line of Lots 75 and 125 to an iron pin on the northern edge of West Castle Road, joint corner of said lots; thence N. 79-11 W. 73.15 feet along the northern edge of said Road to an iron pin; thence around a curve on the edge of West Castle Road, the chord of which is N. 48-56 W. 61.5 feet to an iron pin; thence around another curve still along the edge of West Castle Road, the chord of which is N. 15-53 W. 30.7 feet to an iron pin; thence N. 10-49 E. 16 feet still along the edge of West Castle Road to an iron pin, the point of beginning.
