to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert S. Cutshaw,

All that lot of land situate in Greenville County, Greenville Township, state of South Carolina, designated as Lot No. 15 on plat of record in the RMC Office for Greenville County in Plat Book XX page 15 and being more particularly described according to said plat as follows:

Beginning on the north side of Avery Street at the joint corners of Lots Nos. 15 and 16, thence N. 28-56 W. 128.4 feet along line of Lot No. 16, to rear corner thereof, thence N. 58-47 E. 115 feet to rear corner of Lot No. 14, thence S. 28-56 E. 133 feet along line of Lot No. 14 to front corner thereof on Avery Street, thence S. 61-04 W. 115 feet along Avery Street to point of beginning.
