Hosea Baker, his heirs and assigns, forever:

All that piece, parcel or lot of land with buildings and improvements thereon situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 29 on Shamrock Acres recorded in the R.M.C. Office for Greenville County in Plat Book YY, Page 43 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Kingswood Drive at the joint front corner of lots 28 and 29 and running thence with the common line of said lots S. 55-00 E. 165 feet to an iron pin; thence N. 18-22 E. 88.6 feet to an iron pin; thence N. 55-00 W. 140 feet to an iron pin on the southeasterly side of Kingswood Drive; thence with said Drive S. 35-00 W. 85 feet to the point of beginning.
