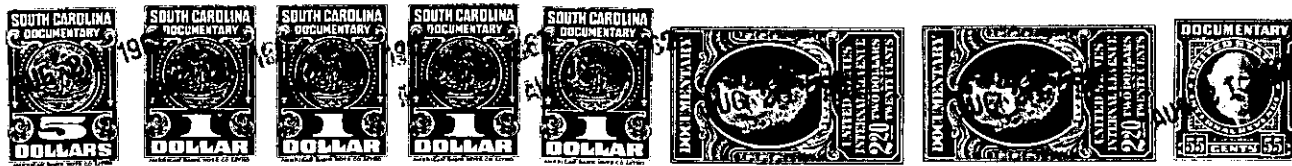
in consideration of Four Thousand Two Hundred Fifty and no/100 (\$4,250.00) Dollars,
