CERTIFICATE OF MARRIAGE

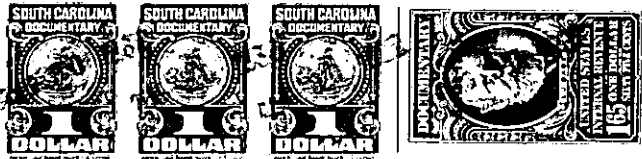
KNOW ALL MEN BY THESE PRESENTS, that I, Florrie E. Greer

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Oscar Eugene Church and June Kay Church

All that certain piece, parcel or lot of land, lying and being situate in Austin Township, Greenville County, State of South Carolina, being known and designated as lot No. 13, Block A on a plat of property of Mrs. B. E. Greer, said plat being recorded in the R. M. C. Office for Greenville County and being more fully described as follows:

BEGINNING at an iron pin on the South Side of West Golden Strip Drive, joint corner with lot No. 12, and running thence S. 30-00 E. 328.4 feet to an iron pin; thence N. 46-30 E. 110 feet to an iron pin; thence N. 30-10 W. 302.2 ft. to an iron pin on West Golden Strip Drive; thence S. 60-00 W. 106.4 feet along West Golden Strip Drive to the beginning corner, and being subject to a 68 foot right-of-way of Duke Power Company which crosses property, and being a portion of the same property conveyed to R.
