Jackson

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, lying and being on the northwesterly side of Old Pelzer Road, near the Town of Piedmont, containing two acres, more or less, adjoining lands of Mrs. Vennie H. Clark, C. L. Garrett and others, and having the following metes and bounds, to-wit:

BEGINNING at a point in the center of the public road at the corner of Alton Cothran land, and running thence along the center of said Road N 63-25 E 2 chains, 80 links to a point in center of the Road; thence N 42 W 7.45 to a point in the center of the Southern Railroad Track; thence along the center of the railroad S 34 W 3.48 to corner of Alton Cothran land; thence along the line of Cothran lands S 48-50 E 5.27 to the beginning corner.
