in consideration of the sum of Fifteen Thousand and No/100ths (\$15,000.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto RALPH E. WELLS:

All that certain piece, parcel or lot of land situate, lying and being on the Southern side of Tuscon Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 97 as shown on a plat of Sections 1 and 2, Western Hills, prepared by Jones & Sutherland, Engineers, dated August, 1959, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 98 and 99, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Tuscon Drive at the joint front corner of Lots Nos. 96 and 97, and running thence with the line of Lot No. 96 S. 20-19 E. 175 feet to an iron pin in the rear line of Lot No. 79; thence with the rear line of Lot No. 79 S. 71-32 W. 46.4 feet to an iron pin; thence with the rear line of Lot No. 78 S. 73-30 W. 64.6 feet to an iron pin at the joint rear corner of Lots Nos. 97 and 98; thence with the line of Lot No. 98 N. 16-43 W. 174.7 feet to an iron pin on the Southern side of Tuscon Drive; thence with the Southern side of Tuscon Drive N. 73-17 E. 36.2 feet to an iron pin; thence continuing with the Southern side of Tuscon Drive N. 71-41 E. 63.8 feet to the point of beginning.

This is the identical property conveyed to the grantor herein by deed of J. Frank Williams, dated June 18, 1962, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 700 at page 440.
