Elizabeth H. Lathem, her heirs and assigns forever:

All that certain tract of land on the west side of the White Horse Road, in the County of Greenville, State of South Carolina, and being known and designated as tract No. 2 in the partition of the W. M. Bynum estate, as shown by subdivision and plat of same made by W. A. Hester, surveyor, May 28, 1930, and having the following metes and bounds and courses and distances, as shown by said plat, to-wit:

BEGINNING at an iron pin in the center of said White Horse Road, southeast corner of tract No. 1, and running along the line of said tract No. 1, S. 76 W. 26.00 chains to an iron pin N. M., thence S. 49 W. 8.87 chains to dogwood O. M., thence S. 30-E. 100 chains to an iron pin N. M. in line of tract No. 3, thence along the line of this tract N. 75 E. 33.00 chains to an iron pin in the center of White Horse Road, thence along the center of said road, N. 5 1/2 W. 4.52 chains to the beginning corner and containing 14 acres, more or less; less, however, a portion of the land conveyed by the grantor August 30, 1957, to C. J. Bowen containing approximately 73/100ths of an acre.

The above-described property is the same inherited by me from my wife, Nettie E. Hawkins, and deeded to me by the grantee by deed dated August 11, 1953, and recorded in Deed Book 483 at page 319 in the R. M. C. Office for Greenville County.
