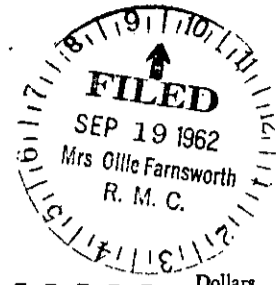

ALL that piece, parcel lot of land in the State and County aforesaid, being known and designated as Lot No. 66, as shown on a plat of Holtzclaw Estates, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 147, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Watkins Circle at the joint front corner of Lots Nos. 65 and 66 and running thence along the joint line of said lots, N. 12-35 E. 240 feet to an iron pin; thence N. 83-20 W. 100.6 feet to an iron pin in the joint rear corner of Lots 66 and 67; thence along the joint line of said lots, S. 12-35 W. 230 feet to an iron pin in the line in Watkins Circle; thence along the northern side of Watkins Circle, S. 77-25 E. 100 feet to the point of beginning.
