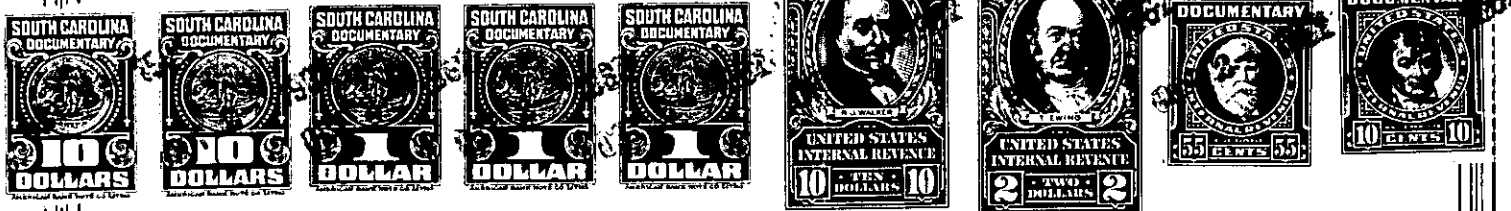

KNOW ALL MEN BY THESE PRESENTS That We, James F. McDonald and
Leila W. McDonald
 in the State aforesaid, in consideration of the sum of _____
Eleven Thousand Five Hundred (\$11,500.00)----- Dollars
 to _____ us in hand paid at and before the sealing of these presents
 by Margaret W. Wade

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by
 these presents do grant, bargain, sell and release unto the said Margaret W. Wade, her
heirs and assigns forever:

all that piece, parcel or lot of land in Greenville Township, Greenville
 County, State of South Carolina being known and designated as the Western
 33 feet of lot number 6 and the Eastern 37 feet of lot No. 5 of
 Block "G" of a subdivision known as Kanatenah, according to a revised
 plat of said Block of property which is recorded in plat book "H"
 at page 288, Greenville County R. M. C. Office, and having the follow-
 ing metes and bounds, to wit:

Beginning at a point on the Northern side of Cureton Street, the joint
 front corner of lots Nos. 5 and 6 of Block "G" and running thence with
 the northern side of Cureton St., N. 63-35 E., 33 feet to an iron pin;
 thence N. 26-30 W., 160 feet to an iron pin; thence S. 63-35 W., 70
 feet to an iron pin; thence S. 26-30 E., 160 feet to an iron pin on
 the northern side of Cureton St.; thence with the Northern side of
 Cureton St., N. 63-35 E., 37 feet to the beginning corner. This is
 the same property conveyed to James F. and Leila W. McDonald by Costa
 J. Manos by deed recorded in deed book 452 page 542, Greenville County
 R. M. C. Office.

ALSO:
 All that lot or strip of land in Greenville County, S. C., five feet
 in width taken from Lot No. SIX (6), and adjoining the above on the
 East, said lot No. 6 being shown on a plat of property known as
 Kannatenah recorded in plat book H page 288, Greenville County R. M.
 C. office and described as follows.

Beginning at an iron pin on the Northern side of Cureton Street at the
 corner of the above described lot, said iron pin being 33 feet east
 from the joint front corner of lots 5 and 6 as shown on said plat
 and running thence with the northern side of Cureton St., N. 63-35 E.,
 5 feet to pin; thence N. 26-30 W., 160 feet to iron pin; thence
 S. 63-38 W., 5 feet to iron pin at the rear corner of the above des-
 cribed lot; thence with the line of the above described lot S. 26-
 30 E., 160 feet to the beginning corner. This is the same property
 conveyed to James F. McDonald by H. Kirk Taylor by deed recorded in
 deed book 459 page 472, Greenville County R. M. C. Office.
