That We, Ralph E., Louis A. & James H. Garlington

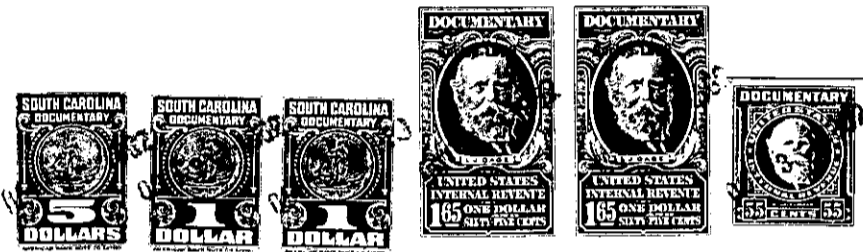
in consideration of the sum of Thirty Two Hundred and no/100 (\$3200.00)----- DOLLARS, in the State aforesaid,

Crawford & Ida C. Crawford, their heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as lot no. 1 on a plat of Shannon Forest recorded in the R.M.C. Office for Greenville County in Plat Book KK, Page 140 and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Shannon Lake Circle at the joint front corner of lots 1 & 2 and running thence with the common line of said lots N. 63-36 W. 199 feet, more or less, to the high water line of Shannon Lake; thence with the high water line of said Lake N. 31-24 E. 30 feet to an iron pin; thence continuing with said high water line S. 75-31 W. 259.9 feet to an iron pin on the northwesterly side of Shannon Lake Circle; thence with said street S. 26-24 W. 200 feet to the point of beginning.

The above lot is conveyed subject to the recorded restrictions applicable to Shannon Forest and to an amendment thereof to be recorded and to the easements and set-back line as shown on said plat.
