KNOW ALL MEN BY THESE PRESENTS, that We, C. S. Boling and Carolyn Boling, of Greenville County

in consideration of exchange of property valued at Ten Thousand, Five Hundred and No/100 - - Dollars, (\$10,500.00) the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Larry G. Shaw, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Bob White Lane, being the major portion of Lot #46 on a plat prepared by Dalton & Neves, Engineers, dated May 1946 entitled "Map of Super Highway Homesites" recorded in the R. M. C. Office for Greenville County in Plat Book P, at Page 53, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Bob White Lane, the joint front corner of Lots 45 and 46 and running thence with the line of Lot 45, S. 14-13 E. 178.2 feet to an iron pin at the joint rear corner of Lots 21, 22, 45 and 46, which iron pin is in the center of a 5-foot easement reserved for utilities; thence with the rear line of Lot 21, S. 72-14 W. 78.8 feet to an iron pin at the joint rear corner of Lots 20, 21, 18 and 46; thence with a new line through Lot 46, N. 21-20 W. 85.2 feet to an iron pin; thence continuing with the new line through Lot 46, N. 88-00 W. 6 feet to an iron pin at the joint rear corner of Lots 16 and 17, which iron pin is in the center of a 5-foot easement reserved for utilities; thence with the line of property belonging to F. J. Hollingsworth, et al., N. 4-15 E. 112.1 feet to an iron pin on the southern side of Bob White Lane; thence with the southern side of Bob White Lane, N. 84-37 E. 60 feet to the beginning corner; being the same conveyed to us by Carolina Rentals, Inc. by its deed dated November 24, 1961 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 687, Page 114.

The description in said deed erroneously included a small triangular parcel which had previously been conveyed by Carolina Rentals, Inc. to William B. Ducker by deed recorded in the R. M. C. Office for Greenville County in Deed Vol. 685, at Page 97.
