Beginning at a stake on Gilders Creek, corner Tract No. 2 and running thence N. 45 E. 2440 feet to the Greenville-Woodruff Road; thence along said road N. 50 W. 577 feet to a stone, thence S. 19.30 W. 294 feet to stone, thence S. 55.20 W. 1998 feet to stone on Gilders Creek, thence along said creek to the beginning corner containing 35 acres, more or less.
