Power of Attorney

KNOW ALL MEN BY THESE PRESENTS, That I, Finis J. Talley, of Greenville, Greenville County, South Carolina, have this day constituted and appointed my brother, Quinton R. Jones, of Columbus, Muscogee County, Georgia, my true and lawful attorney for me, and in my name to (a) buy, receive, lease, or otherwise acquire; to sell, convey, mortgage, pledge, quitclaim, deed, or otherwise dispose or encumbrance of: any property whatsoever and wheresoever situated, be it real, personal, or mixed, upon such terms as my attorney shall think proper. (b) To make, endorse, accept, receive, sign, seal, execute, acknowledge, and deliver deeds, assignments, agreements, certificates, checks, notes, bonds, vouchers, receipts, releases, and such other things necessary, convenient, or proper in the premises. (c) To make deposits or investments in, or withdrawals from, any account, holding, or interest which I may own or hereafter have, or be entitled to, in any banking, trust, or investment institution, including postal savings depository offices, credit unions, savings and loan associations or institutions, and similar institutions, to exercise any right, option, or privileges pertaining thereto; and to open or establish accounts or holdings with such institutions in my name or in my said attorney's name or in both our names jointly, either with or without right of survivorship. (d) To institute, prosecute, defend, compromise, or otherwise dispose of legal, equitable, or administrative hearings, actions, suits, or otherwise engage in, litigations in connection with the premises. (e) To act as my attorney in fact or proxy in respect to any policy of insurance on my life or health, and to exercise any right, privilege or option which I may have thereunder or pertaining thereto.

And I hereby declare that any act or thing lawfully done hereunder by my said attorney shall be binding upon myself, my heirs, and legal and personal representatives, and assigns, unless and until revocation of this instrument either in writing or by my death.

Giving and granting unto my said attorney full power and authority to do any and all acts necessary and proper to be done in and about the premises.
