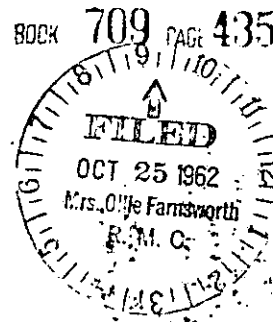
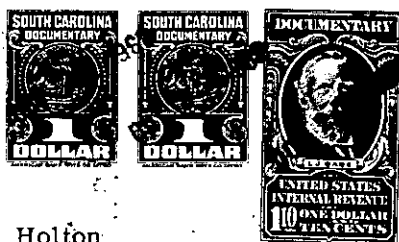

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell, and release unto William O. Scott, his heirs and assigns, forever:

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot 3, Section No. 1, of Peace Haven as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "VV" at Page 83, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Elm Street at the joint front corner of Lots 3 and 4 and running thence along line of Lot No. 4, N. 65-18 E. 200 feet to an iron pin; thence S. 21-24 E. 110 feet to an iron pin at the joint rear corner of Lots 1 and 3; thence along the rear line of Lots 1 and 2, S 65-18 W. 200 feet to an iron pin on the eastern side of Elm Street at the joint corner of Lots 2 and 2; thence along the eastern side of Elm Street, N. 21-24 W. 110 feet to the beginning corner.
