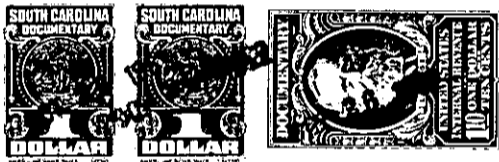

Office for Greenville County, in Platt Book LL at page 137, and having the following metes and bounds, to-wit:

BEGINNING at a point on the northern side of Old Spartanbrug Road at the joint front corner of Lots 122 and 123 and running thence N. 06-53 W. 200 feet to a point at the joint rear corner of Lots 122 and 123; thence S. 83-07 W. 99.6 feet to a point in the eastern side of Beaufort Street at the joint corner of Lots 123 and 124; thence with the eastern side of Beaufort Street S. 15-37 W. 85.7 feet to a point; thence continuing with the eastern side of Beaufort Street S. 07-12 W. 72.8 feet to a point; thence still continuing with the eastern side of Beaufort Street S. 06-53 E. 35 feet to a point; thence following the curvature of the northeastern intersection of Beaufort Street with Old Spartanburg Road, the cord of which is S. 51-53 E. 21.2 feet to a point; thence with the northern side of Old Spartanburg Road N. 83-07 E. 135 feet to the point of beginning."
