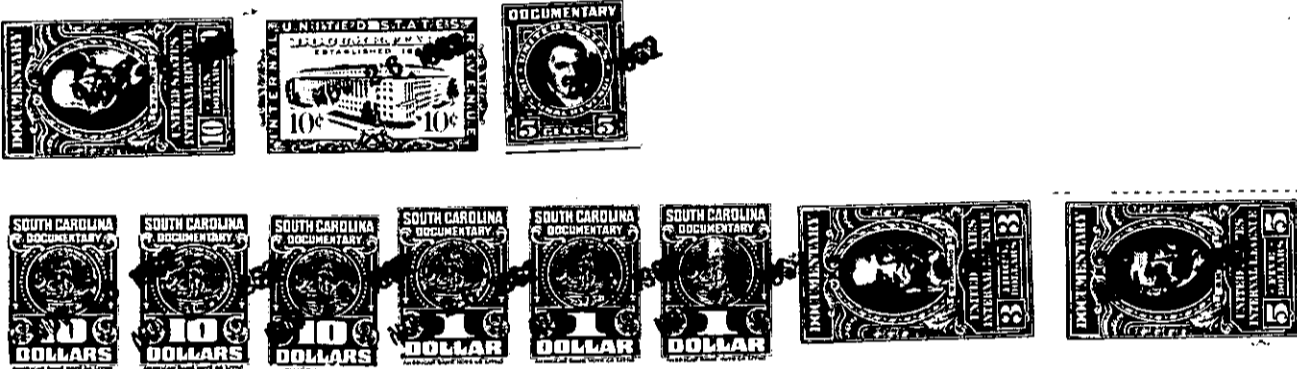

in consideration of Sixteen Thousand, Five Hundred and No/100-----(\$ 16,500.00)---- Dollars,
 the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
 unto Tommy M. Smothers, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the southern side of East Lee Road, being known and designated as Lot No. 9 of a subdivision known as Oakwood Acres as shown on plat thereof prepared by J. Mac Richardson, R. L. S., September, 1959, revised October 1, 1959 and recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 135, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of East Lee Road, joint front corner of Lots 8 and 9; running thence along the joint line of said lots, S. 22-55 E. 175 feet to an iron pin at the joint rear corner of Lots 27 and 28; thence along the rear line of Lot 27, N. 67-05 E. 90 feet to an iron pin at the rear corner of Lot 10; thence along the line of that lot, N. 22-55 W. 175 feet to an iron pin on the southern side of East Lee Road; thence along the southern side of East Lee Road, S. 67-05 W. 90 feet to the beginning corner; being the same conveyed to me by Leslie & Shaw, Inc. by deed dated April 27, 1962, recorded in the R. M. C. Office for Greenville County in Deed Vol. 697, page 185.
