KNOW ALL MEN BY THESE PRESENTS, that I, D. J. Vaughn, of the County of Greenville, State of South Carolina,

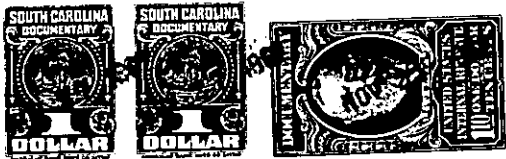
in consideration of Eight Hundred (\$800.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto C. L. McCutcheon, his heirs and assigns,

All that piece, parcel or tract of land in Dunklin Township, Greenville County, State of South Carolina, on the northwestern side of a County Road known as the Hillside Road, near Hillside Church and Reedy River, and according to a plat and survey made by C. O. Riddle, R. L. S., May 8, 1957, having the following metes and bounds, to-wit:

BEGINNING at a point in center of said Hillside Road, iron pin, at the joint corner with a six-acre tract of land heretofore conveyed by the Grantor herein to T. V. Moore, and running thence with line of said Moore property, N. 58-34 W. 328.2 feet to a point, pine stump, joint corner with the said Moore and the Thompson properties; thence, crossing a branch and along the line of the said Thompson property, N. 20-15 W. 1651.8 feet to a stake, joint corner with other property of the Grantor herein; thence with the line of Grantor's other property and crossing said branch again, S. 58-00 E. 1634 feet to a point, iron pin, in center of said Hillside Road; thence along the center of said Hillside Road, S. 32-00 W. 1008 feet to the point of beginning; and containing Twenty Two and 93/100 (22.93) acres, more or less.

The above described property is a part of the same conveyed to me by W. M. Thompson and Hettie Mae G. Thompson by deed recorded in the R. M. C. office for Greenville County, S. C.

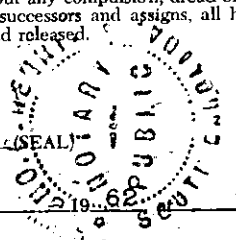
RENUNCIATION OF DOWER
