All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 22 of a subdivision known as Sherwood Forest according to a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book GG, at pages 70 and 71, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of LeGrand Boulevard at the joint front corner of Lots 21 and 22, and running thence with the joint line of said lots, N. 40-49 E. 160 feet to an iron pin at the joint rear corner of Lots 21 and 22; thence with the rear line of Lot 22, N. 49-11 W. 70 feet to an iron pin at the joint rear corner of Lots 22 and 23; thence with the joint line of said lots, S. 40-49 W. 160 feet to an iron pin on the northeastern side of LeGrand Boulevard, joint front corner of Lots 22 and 23; thence with the northeastern side of said LeGrand Boulevard, S. 49-11 E. 70 feet to the point of beginning.
