to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said BRUCE MOSELEY, his heirs and assigns, forever:

ALL that lot of land situated on the North side of West Belvedere Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot 121 on plat of South Forest Estates, made by Pickell & Pickell, Engineers, August 29, 1955, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book GG, Page 181, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of West Belvedere Road, at joint front corner of lots 120 and 121, and runs thence with the line of Lot 120, N. 5-36 W., 125 feet to an iron pin; thence S. 84-21 W., 100 feet to an iron pin; thence with the line of Lot 122, S. 5-36 E., 125 feet to an iron pin on the North side of West Belvedere Road; thence along West Belvedere Road, N. 84-21 E., 100 feet to the beginning corner.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

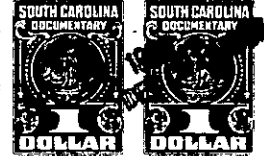
