All those lots or tracts of land in Greenville County, South Carolina on the northeastern side of Clairmont Drive, near South Carolina Highway No. 291 being shown and designated as Lots Nos. 134 and 135 on a Plat of Piney Mountain Park made by Brodie and Bedell, Engineers, dated August 30, 1913, recorded in the R.M.C. Office for said County and State in Plat Book E at page 201 and having according to said Plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northeastern side of Clairemont Drive, joint front corner of LotsNo. 134 and 133, which is now owned by William R. Timmons, Jr., and running thence along the joint line of said lots S 56 - 25 W. 287 feet to an iron pin; thence N 11 - 15 E., 175 feet to an iron pin, common corner of Lots Nos. 134 and 135; thence along the line of Lot No. 135 and crossing a branch N 77 - 45 W., 891 feet to an iron pin; thence N 13 - 0 W., 269 feet to an iron pin; thence recrossing said branch S 77 - 30.E., 891 feet to an iron pin, the rear corner of triangular shaped Lot No. 136 now owned by William R. Timmons, Jr.; thence along the line of Lot No. 136 S 77 - 30 E., 301 feet to an iron pin on the northeastern side of Clairemont Drive; thence with the curve of Clairmont Drive and running in a southwesterly direction with the line of Lots Nos. 134 and 135, 225 feet to an iron pin, the beginning corner.
