All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being located one block off old Spartanburg Road and being Lots Nos. 14 and 15 according to plat of property of Walter Goldsmith, Trustee, made by R. E. Dalton December 1940 and being more particularly described as follows:
