KNOW ALL MEN BY THESE PRESENTS, that We, Rufus B. Atkins and Louise G. Atkins,

in consideration of Two Hundred Fifty Seven and No/100 - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Samuel B. Wasson and Ida E. Wasson, their Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Butler Township, about one mile south of Batesvill, lying north from the Giffith Road and lying to the rear of the present lot of the grantees herein, and being a part of the same land conveyed to us by deed from J. Wayman Smith January 14th 1953, recorded in the office of the R. M. C. for Greenville County in Deed Book 470 at page 171, and having the following courses and distances, to wit:-

Beginning on an iron pin, the northwest corner of the present lot of the grantees herein, and runs thence with the rear line of the said present lots, N. 65-30 E. 377.8 feet to an iron pin, the northeast corner of the grantees lot and on the line of H. DeFaux lot; thence with the DeFaux lot, N. 38-43 W. 16.4 feet to a point in gully, De Faux corner; thence with the gully and the DeFaux line, N. 15-13 E. 89.8 feet to a bend; thence N. 13-12 W. 128.7 feet to a cluster of Maples on south bank of branch; thence with the branch as the line with the following two traverse lines: S. 79-10 W. 150 feet to a stake, witnesses on Poplar; thence S. 75-30 W. 315 feet to an iron pin on the south bank of branch; thence S. 24-30 E. 301 feet to the beginning corner, containing Two and Fifty Seven One-hundredths (2.57) acres, more or less.
