 the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
 unto Donald O. Turner, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot #28, as shown on a plat of Oakwood Acres, prepared by J. Mac Richardson, dated September 1959, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book MM, at Page 135, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Oakwood Avenue, the joint front corner of Lots #28 and #29, and running thence along the line of these lots, N. 15-48 W. 208.8 feet to an iron pin; thence N. 67-05 E. 107 feet to an iron pin at the joint rear corner of lots #28 and #27; running thence S. 22-22 E. 180.9 feet to an iron pin on the northern side of Oakwood Avenue; thence along the northern side of Oakwood Avenue, S. 56-49 W. 58 feet to an iron pin; thence continuing along the northern side of Oakwood Avenue, S. 54-22 W. 74.6 feet to an iron pin, point of beginning; being the same property conveyed to me by Leslie & Shaw, Inc. by its deed dated August 10, 1962, recorded in the R. M. C. Office for Greenville County in Deed Vol. 706, at Page 534.
