All that certain piece, parcel or lot of land situate in Greenville County, State of South Carolina in Chick Springs Township, being known and designated as Lot No. 72 of Belmont Heights as shown on plat recorded in Plat Book QQ at Pages 160-161 and being more particularly described as follows:
