in consideration of NINE HUNDRED FIFTY AND NO/100-----(\$950.00)----- Dollars,

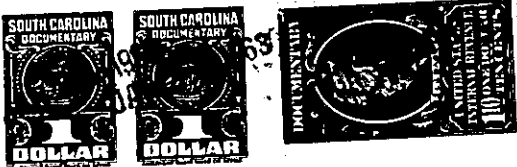
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. ODELL SHAVER, HIS HEIRS AND ASSIGNS:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin, and being known and designated as Lot Number 101 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 76-77, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Paxton Avenue at the joint front corner of Lots 101 and 102 and running thence with the Northern side of Paxton Avenue S 77-53 E 80.9 feet to a point; thence following the curvature of the Northwestern intersection of Paxton Avenue with North Golden Strip Drive (the chord of which is N 53-36 E 33.2 feet) to a point; thence with the Western side of North Golden Strip Drive N 5-06 E 151.3 feet to a point at the joint rear corner of Lots 100 and 101; thence N 77-53 W 84.4 feet to a point at the joint rear corner of Lots 101 and 102; thence S 12-07 W 175 feet to the point of BEGINNING.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.
