FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is JANS OF GREENVILLE, INC.

THIRD: That the principal place of business is 409 E. North St., Greenville, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to establish, maintain, conduct and carry on a general merchandising business; and in conjunction therewith to manufacture, produce, buy, import and otherwise acquire, own, store, hold, use, sell, export, distribute, lease, pledge and otherwise dispose of and generally deal in and with, at wholesale or retail, as principal or agent for others, upon commission, consignment or otherwise, goods, wares, commodities, merchandise and personal property of every class, name, nature and description. payable in money, or in labor or in property at its par value , when and as

required by the board of directors

SIXTH: That the number of shares into which the capital stock is divided is Two Thousand (2,000)

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 28th
