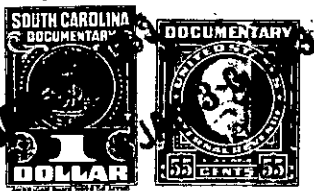

KNOW ALL MEN BY THESE PRESENTS, that I, John P. Wright

in consideration of Four Hundred and No/100 (\$400.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Mrs. Violet M. Stallings, her heirs and assigns forever:

ALL that certain piece, parcel or lot of land in the State and County aforesaid in Gantt Township, being shown and designated as Lot No. 10 on a plat of the property of John P. Wright by C. O. Riddle, R. L. S., dated July 28, 1958, and having according to said Plat the following courses and distances, to wit:

BEGINNING at an iron pin on the Northwest side of a 50 foot easement for ingress and egress, being the joint front corner of Lots Nos. 2 and 10 as shown on the plat, and running thence N. 55-00 W. 150 feet to an iron pin; thence S. 35-00 W. 75 feet to an iron pin; thence S. 55-00 E. 150 feet to an iron pin on Northwest side of 50 foot easement; thence N. 35-00 E. 75 feet along the Northwest side of said easement to an iron pin, the beginning corner.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)' heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
