in consideration of ONE THOUSAND SEVEN HUNDRED AND NO/100-----(\$1,700.00)-----Dollars,

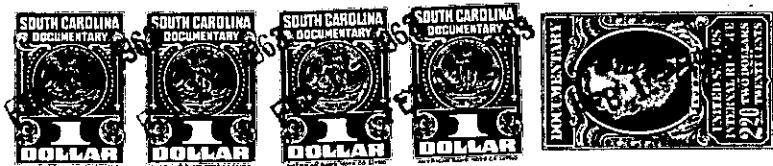

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated at Lot Number 29 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R.M.C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Glacier Street at the joint corner of Lots 28 and 29 and running thence with the Southwestern side of Glacier Street N 25-13 W 115.7 feet to a point; thence following the curvature of the Southwestern intersection of Glacier Street with Salem Court (the chord of which is N 74-46 W 38 feet) to a point; thence with the Southeastern side of Salem Court S 55-40 W 135.3 feet to a point at the joint corner of Lots 29 and 30; thence S 25-13 E 118.9 feet to a point at the rear corner of Lot 29; thence N 64-47 E 162.5 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.
